Edna Collins, a recently homeless individual, shared her experience going through the process of getting housing assistance with the Fresno Housing Authority. She discussed how she became homeless in the last two weeks. She stated that she spoke with a staff member that she described as needing more "sensitivity training" and "needs to work in the back". She did not find that individual very friendly. She further mentioned that she provided documentation verifying that she recently became homeless, and even with the documentation, she needed an officer to certify her living in her car. She mentioned that families should be able to go into an office and be treated with respect and listened to in a respectful manner. She stated that Fresno Housing Authority is creating blockades for people to remain homeless, and that she applied for section 8, and never received a voucher.
